Today, we are honoring Drs. Dankle, Brunson, and Lee and their staff because of their partnership and participation with our Dental Referral Program. As I mentioned, this Program is our collaboration with area dentists who agree to provide dental care at a discounted, sliding-scale rate to low-income uninsured adults. The Dental Referral Program has an emphasis on preventative care and works to make it possible for our community members to find an affordable dental home.

Drs. Dankle, Brunson, and Lee have a practice that has been serving the Champaign-Urbana area for over 25 years and they joined the Dental Referral Program in 2011. They have since directly contributed to the increased success of the Program and upon their agreement to partner with us, more the doubled the number of new patient appointments that we could offer to our clients each month.

Since they joined the program, Drs. Dankle, Brunson, and Lee and their staff have been wonderful partners. They are flexible and understanding to the needs of their patients, and on several occasions, they went out of their way to ensure that their patients were able to find a low-cost oral surgeon. If you know how expensive and exclusive oral surgery services are, then you may understand just how pleased I was to find out that the doctors had referred several clients to an oral surgeon who would accept their designated Dental Referral Program discount at the dentists' request.

Recently, I received a call from a client who had a bad experience at a local dentist and was hoping for me to refer her elsewhere. I referred her to Dr. Brunson, and I felt comfortable in doing so, as he has been my dentist since I was a young girl. Several days later my client called back for the sole purpose of letting me know just how happy she was with the care that she received at Dr. Brunson's office. The tone and feeling in her voice had completely changed and I could tell just how relieved she was to be in the care of a dentist that she could trust.

Drs. Dankle, Brunson, and Lee and their staff are making a tremendous impact on our community by providing affordable quality dental care to our low-income community members.
