## Where does my Medicare 100/ Plus discount apply?

The Medicare 100/Plus Discount Program discount applies to a variety of services provided by OSF HealthCare Heart of Mary Medical Center. Bills from the following providers listed below are covered by the Medicare 100/Plus Discount Program:

- OSF HealthCare
- OSF Medical Group
- Shemauger Emergency Physicians
- East Central Illinois Radiology
- American Anesthesiology
- Alverno Labs
- OSF/Pro Ambulance
- All other participating physicians (please see green handout you receive with your approval)

The program may also help with some of your bills from OSF Sacred Heart Medical Center in Danville. <u>The</u> <u>program does NOT cover Christie Clinic</u> <u>or Danville Polyclinic bills.</u>

Medicare Advantage Plans: If you have a Medicare Advantage plan (like an HMO or PPO), it is important that these providers are also in your plan's network for the program to be able to help discount your bills.

### Will my discount be automatically applied to all OSF HealthCare Bills?

Due to the fact that the billing for these services is not centralized, the Medicare 100/Plus Discount Program adjustment may not be automatically applied. To ensure that your discount is applied, be sure to present your Medicare 100/Plus blue card whenever you use services through OSF.

If you receive a bill that has not been properly discounted, you have two options. You may send a copy of your card in lieu of payment as proof of your discount. You can also call the Medicare 100/Plus Discount Program at (217) 352-6533 to have us assist in getting your bills adjusted.

If you have been approved for a 100% discount, you should not receive another bill after your account has been adjusted. If you have been approved for a sliding-scale discount, you should receive an adjusted bill in the mail reflecting your discount.

## The Medicare 100/Plus Discount Program is a

collaboration between Champaign County Health Care Consumers and OSF HealthCare. It offers Medicare beneficiaries some peace of mind with their health care costs.

### What is the Medicare 100/Plus Discount Program?

The Medicare 100/Plus Discount Program offers eligible Medicare beneficiaries free and discounted care at OSF HealthCare Heart of Mary Medical Center, OSF Medical Group, and several other providers. This program offers seniors and people with disabilities who have Medicare the assurance that they have access to affordable health care.

Program members will qualify for a discount off their out-of-pocket medical costs at participating OSF providers.

The Medicare 100/Plus Discount Program is a financial discount program, <u>not</u> insurance.

#### Who is eligible for this Program?

Eligibility for the Medicare 100/Plus Discount Program is based on:

- 1. Medicare status
- 2. Household Income

Medicare Status: You must have both Medicare Part A (hospital) and Medicare Part B (medical). <u>Program</u> providers must be in network for any Medicare Advantage or Medicare replacement plan you have.

Household Income: You must meet the OSF financial assistance guidelines.

#### How do you apply?

Applying for the Medicare 100/Plus Discount Program is **free** and easy with a short application process.

**Step 1:** Call CCHCC at (217) 352-6533 and ask for the Medicare 100/ Plus Discount Program. We can answer questions and schedule an appointment to complete an application. If you are unable to come to an appointment, we will help you to complete an application over the phone and through the mail.

**Step 2:** Prepare for your appointment. A CCHCC advocate will discuss with you what documents you will need to provide. They generally include: your Medicare card, Social Security benefit statement, and other papers to document all of your household's sources of income (like pension statements, paystubs, income tax return, and/or a checking account statement).

**<u>Step 3</u>**: CCHCC will help you complete the application. We will make copies

of the required documents, assist in filling out the application, and submit your application materials to OSF for processing.

**<u>Step 4</u>:** Once approved, you will receive a letter from CCHCC notifying you of membership, the level of discount you will receive, as well as a blue membership card.

Show your blue membership card every time you visit OSF HealthCare Heart of Mary Medical Center (including the ER) or a participating provider's office.

# Do I need to renew my membership?

Yes. Your discount level is valid for a 1 year period. Members must renew their membership to continue to receive a discount. You will be contacted when it is time to renew!
