

## TAKE ACTION – SUBMIT YOUR TESTIMONY IN SUPPORT OF HB 311!

Submit written testimony to CCHCC explaining why you support HB 311 and a single-payer health care plan for Illinois.

CCHCC will deliver written testimonies to the IL House Health Committee hearing on HB 311 on Tuesday, March 24, 2009.

**Who can submit testimony?** Everyone from the uninsured, underinsured and well-insured, to students and seniors can express their support for HB 311, single-payer health coverage for Illinois.

### **What should you include in your testimony?**

Testimony should be one to two pages in length, and you may include a personal story in which you or someone you care about has been affected by the current health care access crisis, medical debt, or problems with private insurance which would be virtually eliminated if a single-payer insurance program was implemented here in Illinois. You can also provide concrete examples of how your life would be affected by a universal health care plan that covers all Illinoisans. Or you can simply state who you are (as a resident of Illinois), and express your support for the legislation. *All testimony should include a clear statement specifically declaring your support for HB 311 and single-payer health care, and a statement urging the legislators to support HB 311!*

### **Sample testimony:**

I believe that every single Illinois resident deserves quality and affordable health care. the people, Illinois has the opportunity to be a champion of single-payer health care. That is why I am support passage of House Bill 311 – the “Health Care for All Illinois Act” and single-payer health care for all Illinoisans. I urge you to support HB 311 by becoming a co-sponsor of the legislation and voting yes for HB 311. Thank you.
