CONSUMER CANDIDATES VICTORIOUS IN HSA ELECTION

Thanks to all those who participated and voted in the September 29 election of the Champaign-Ford Subarea Advisory Council of the Health Systems Agency. The CCHCC was delighted with the turnout and results. In preparation for the election, we enlisted and endorsed consumer and provider candidates who have demonstrated concern and competence in promoting good health and improving local health care planning. Of the twelve contested seats, fully five of our endorsed candidates were elected and will now join the council. In addition, a CCHCC member introduced a resolution assuring election and representation to two candidates from Ford County, which had not been adequately represented in the past. Thus, CCHCC was instrumental in electing seven of twelve candidates to the local health planning board! We are proud to have stimulated such participation. An independent health consumer organization can make a difference.

HEALTH AND AGING FORUM HELD

The second in a series of educational forums on health issues was sponsored by the CCHCC on September 6. The focus was on "health and aging" and involved active discussion of nutrition, physical fitness, and mental health issues from a "senior" perspective. CCHCC ORGANIZATIONAL MEETING HELD

A CCHCC organizational and new member meeting was held at the Urbana Civic Center on September 20. Those in attendance vigorously voiced their priorities for local health planning. Three committees were formed to formulate action proposals and programs in areas of concern. A health information committee (Judy Yeager, 333-9897, Paul Wilson, Mike Doyle, Janet Patzer, Barry Checkoway) will develop a consumer handbook to local health services for those with developmental disabilities. A health educational forum committee (Margie Checkoway, 344-5727, Doug Arnold, George Bell, Shirley Moore) will develop forums for the coming year. A health planning committee (Mike Doyle, 344-8896, Joe Ahearn, Donna Stimpson, Henry Hadley, Henrietta DeBoer) will develop a program aimed at achieving more consumer involvement in local health planning. Each committee will report on its progress at the next CCHCC meeting.
