Local Consumers Carry Message to Springfield

"No Health Care, No Peace!"


That was the battle cry as members of the Health Care Consumers joined with over 1,000 other citizens during Health Care Action Day in Springfield on April 22.

Organized by the statewide
Campaign for Better Health Care, the
event drew activists from the length
and breadth of Illinois. Cars and
buses converged from a total of 45
cities and towns, including Aurora,
Belleville, Champaign, Chicago,
Danville, Decatur, East Alton, East St.
Louis, Granite City, Peoria, Rockford,
Rock Island, Urbana, and dozens of
smaller communities.

The common goal of all who came was simple: to let our elected officials know that nothing less than single-payer, universal health care would suffice to cure the ills of the current system.

The day began with an 11:00 AM briefing at the Howlett Building, where representatives of the Campaign distributed information on PAC contributions made by the State Medical Society to individual legislators during last fall's elections.

Participants then moved to the Capitol Rotunda for a 12:30 rally, where dozens of state senators and representatives attacked the Medical Society and insurance industry's efforts to defeat the Illinois Health

Children's Health Committee Forming in Champaign County

For the past three months we have been working to establish a Children's Health Task Force. Our decision to form this task force is in response to growing concerns, both within Champaign County and the nation, over the steady increase in child poverty and the lack of children's health insurance. So far, the group has identified immunizations and nutrition as priorities for study and action. Initially we have been in contact with members and clergy in the rural areas of the county to get their opinion on how these issues affect their community. Presently the group's main focus is on making school breakfasts (a federally funded program) available in all public schools in the county. Dental Referral Project Moves Forward

The Health Care Consumers' initiative to increase access to dental care for the low-income community of Champaign County is making steady progress. This initiative, known as the Dental Referral Project, will establish a program whereby low-income residents can receive dental care at reduced rates from participating providers.

As reported in the last newsletter. Health Care Consumers surveyed over 600 low-income residents to determine their dental needs. This survey, released on April 7, spurred the development of a Dental Advisory Committee, composed of local dental providers and community leaders, to work with Health Care Consumers to develop the referral program. The committee has met four times in the past two months in order to bring this program to life.

"I'm encouraged by the progress we have made so far," stated project coordinator Jason Gascovne. "Everyone is committed to making this program work, and we all want to see it operating as soon as possible."

Current plans call for the program to be open to adults over the age of eighteen who do not have insurance, yet make too much money to qualify for Medicaid. This group, commonly referred to as the working poor, usually cannot afford

to pay for dental services out of their own pocket. As a result, they either go without services, or receive their services at Frances Nelson Health Center. Frances Nelson is also the only place where Medicaid recipients can be assured of receiving care, so the dentist there is overwhelmed with patients. In the month of March, Frances Nelson saw over 500 dental patients. The referral program would allow for some of these working poor patients to be seen by private dentists for a reduced rate. decreasing the patient load at Frances Nelson, and thereby increasing the number of Medicaid patients who can receive treatment.

Although questions concerning the details of how the program will operate and what services it will provide are still being discussed, it appears the program will be very comprehensive. The current discussions include provision of a full range of services, including emergency, preventive, restorative, and dentures, although the latter still requires a great deal of negotiation before it is solidified. Discussions are also still underway concerning what the cost of services will be to the patient. "We still would like to have the system in place and operating at full capacity by this fall," commented Gascoyne.

CMS Renews Biodyne Contract Despite Employee Complaints

Despite many complaints from state employees and a resolution unanimously passed by the University of Illinois Faculty Senate, Central Management Services has renewed its contract with Illinois Biodyne for management of mental health benefits. CMS cited cost as the overriding factor in its decision and also stated that, in previous years, employees had abused the system. No figures were offered to back up this claim, and CMS admits that it had no system in place to monitor the use of these benefits.

Locally, consumers continue to be concerned about the limited number of providers who are part of the Biodyne network, and Biodyne's insistence on behaviorist treatment even when that is not an appropriate therapy. As of now, only one psychiatrist serves Champaign County, and that doctor commutes from Decatur. Contrary to Biodyne's claims, patients find it almost impossible to get approval to see providers outside the network.

The Senate resolution cited employee complaints, CMS' failure to oversee Biodyne's operations, and the lack of information provided to employees about benefits and Biodyne's methods of operation. The Senate called on CMS to seek new management for mental health benefits, and to reimburse employees for unjustified expenses incurred because of Biodyne's policies. The Senate also directed their representatives to raise these issues with state-wide faculty working groups.

Because neither Biodyne nor CMS shows any intention of correcting these problems, the U of I Senate Benefits Committee is recommending that employees needing these benefits switch out of the Quality Care plan. Providers and consumers are working together for legislation to regulate the operation of managed care companies like Biodyne.

CCHCC Awards Dinner Honors Local, National Leaders

"If the administration doesn't approve this kind of program [single-payer], I'm afraid we have elected a one-term president," stated U.S. Rep. John Conyers, keynote speaker at Health Care Consumers' 16th Annual Awards Dinner. Conyers provided Health Care Consumers' members with an insider's view of how health care reform is being looked at in Washington.

The theme of this year's dinner was, "Universal Health Care: Do the Right Thing." Imani Bazzell, Acting Director of the Health Care Consumers, stated the theme was "a celebration of an administration that is serious about health care reform." For those in attendance, the event was a chance to learn what reform looks like from "inside the beltway."

Rep. Convers was the recipient of Health Care Consumers' Legislator of the Year Award, in recognition of his sponsorship of the single-payer universal health care bill in the House of Representatives. Convers, a 15 term Democrat from Detroit, has made social justice and economic development the focal points of his career in public service. Among his successes are the Martin Luther King Holiday Bill, the Racial Justice Act, the Voter Registration Reform Act, and the Civil Rights Act of 1991. Conyers urged those in attendance to push Clinton and Congress to stand up to the special interests, and support a single-payer system.

For many, the highlight of the evening came when longtime Health Care Consumers Director Mike Doyle was honored with the inaugural **Mike**

Doyle Activist of the Year Award. This award will honor individuals for their efforts to achieve social justice in the community. "It was a complete surprise," stated Doyle. "I am honored to have this award named after me."

support of A Woman's Place through
his dental practice.

The Campaign for Better Health Care received the Leadership Award for their outstanding work in leading the fight for a single-payer universal health care system, at both the state and national level.

The Henrietta DeBoer Volunteer of the Year Award was presented to Bettina Chapman, in recognition of her outstanding committment and

willingness to volunteer generous amounts of her time.

The Dr. Elsie Field Provider of the Year Award was presented to Dr. Frank Wrestler for his years of practice here in the community. Dr. Wrestler has always made himself accessible to his patients, works with them to understand the health care system, and has always gone beyond the call of duty to help his patients.

Consumer Reports received the Excellence in Health Care
Reporting Award for their 3-part series looking at the health care crisis and possible solutions to the problem.

The coveted Golden Bedpan
Award, for the greatest disservice to
health care consumers, went to
Biodyne Corporation and the Illinois
Department of Central Management
Services for their butchering of
mental health benefits for state
employees (see story on page 3).

Security Act of 1993 (HB 1459). These special interests have consistently opposed any meaningful health care reform, and remain the single largest obstacle to accessible, affordable health care.

Following the rally, a procession formed to take the message of "Health Care for All" to Governor Edgar's office. Members of the Champaign contingent brought thousands of fake \$100 bills, representing the PAC contributions of the Medical Society and insurance industry. Citizen lobbyists placed these bills in large money sacks as they filed past the governor's office, to let him know that we are tired of these special interests buying off the reforms that are needed to alleviate the suffering of Illinois residents.

From the governor's office, the volunteers moved to the third floor of the Capitol building, to begin the task of lobbying individual legislators in support of HB 1459. This bill would mandate a statewide, universal access health care system by January 1, 1996. While leaving the details of implementation to a bipartisan commission, the bill specifically required:

 Universal access to a full range of preventive, acute, and long-term services;

- Improved quality of health care services to Illinois residents;
- * Portability of coverage regardless of changes in job status;
- Local and regional consumer participation in decisions about health care delivery, financing, and provider supply;
- * Controls on capital and overall expenditures;
- Global budgeting for health care providers; and
- Elimination of unnecessary duplication of health care facilities and services.

At the start of the day, 52 of the necessary 60 representatives had committed to voting for the bill. As the citizen lobbyists buttonholed their

respective legislators, that number began to grow, and it was clear that the pressure was on. At 2:00, the count stood at 57; by 2:30, based on what the legislators told their constituents, we had the required 60 votes.

After a twenty minute floor debate, the roll call began. When it finished, the citizens of Illinois had once again been betrayed by those they trust to represent their interests. Three Democratic representatives who had previously indicated their support of HB 1459 (two of whom were actually cosponsors!) reneged on their commitments to their constituents, and failed to vote yes.

Harold Murphy of Markham (one of the cosponsors) voted present, while Judy Erwin of Chicago (also a cosponsor) and Jeff Schoenberg of Skokie, both of whom voted for the bill in the House Health Care Committee, actually voted against HB 1459 on the floor. Their defections left the bill with only 57 votes in favor, three short of the 60 needed.

Whether these reversals reflected genuine crises of conscience, or the less-than-subtle manipulations of the medical and insurance industries, the unfortunate fact is that Illinois citizens must once again bear the brunt of our grossly inequitable and increasingly unaffordable health care system, at least until next year.

With each new revelation concerning Bill Clinton's long-awaited health care plan, it becomes increasingly clear that it will do little to remedy the runaway costs or two-tiered stratification of our current system. What it will do, however, is leave an opening for individual states to take the lead in forging new solutions that can work.

The spirit and determination demonstrated by the 1,000 plus volunteers and health care advocates at this year's Health Care Action Day guarantees that Illinois will continue to be at the forefront of this battle. We will force next year's gubernatorial and legislative candidates to declare their allegiances: either to the fat cats and special interests who continue to profit at the expense of the medical and economic health of the public; or to the citizens of Illinois, and the cutting edge of health care reform.
