Dr. Quentin Young to Speak at CCHCC Awards Dinner

Dinner Scheduled for Saturday, March 14 at the Chancellor

Dr. Quentin Young, a nationally recognized leader in public health policy and medical and social justice issues, will provide the keynote address at CCHCC's 21st Annual Awards Dinner, which will be held on Saturday, March 14, 1998 at the Chancellor Hotel. A social hour will begin at 6:00 P.M., followed by a buffet dinner at 6:30. The Chancellor Hotel is located at 1501 S. Neil in Champaign. Child care will be available.

The theme for this year's Dinner is "Our Health, Our Voice, Our Choice."

CCHCC's recent work has highlighted more than ever the problem of "people vs. profits" in health care and the need for consumers to make their needs and priorities the driving force in shaping the future of our health care system. Dr. Young, who has been fighting the corporate takeover of medicine in America, will speak about public health, the clash between "good health care" and "big money," and the ways that citizens and communities can organize to make their voice heard and bring about useful, lasting changes. Dr. Young is a practicing physician, President of the American Public Health Association, and also serves as the National Coordinator of Physicians Continued on page 7

CCHCC Task Force Sees Changes

Carle Suspends Interest Charges

Carle Clinic reports changing two key elements of its billing policy, a sign that CCHCC's Medical Billing Task Force (MBTF) is succeeding in its campaign. First, the Clinic claims that it now credits payments to patients' accounts on the same day they are received. Second, beginning in August, the Clinic—in what it calls a temporary act of "courtesy"—stopped charging interest on unpaid patient balances.

Task Force members will be investigating and watching to see that

practices really do bear out Carle's claims, but clearly it is a significant victory for MBTF and the East Central Illinois community.

With Carle Clinic refusing to admit to systemic billing problems or to meet with MBTF members to discuss such problems, the Task Force held a press conference on July 17, 1997. The event called attention to consumer complaints and Carle's behavior, and a new CCHCC report, "Consumers

First Budget & Levy Approved for County Health Department

Consumers Consider It Just a Start...

Friends of Public Health members. as well as all Champaign County residents, have something big to celebrate! The tax levy to support public health services for the county finally passed by the County Board. In addition, Board of Health members have met with Gale Fella. Administrator of C-U Public Health District, to finalize the terms of the contract to begin providing services to all county residents. The hard work of hundreds of Friends of Public Health volunteers paid off this November, marking the one year anniversary of when the Referendum passed.

The message from members of Friends of Public Health Coalition was of both relief and excitement, recognizing that their years of hard work had finally produced the results they'd been hoping for. "It's great," said Liz Mazur, a volunteer for FPH. "It's good to see the tax levy pass so that services can get started for County residents. I'm glad to be a part of such a huge victory."

Jan Anderson, a volunteer who has been with FPH since the beginning, showed signs of relief. "I'm glad we finally got to this point. It's kind of symbolic how this happened just over one year after we got the referendum passed. It's hard to believe that it's taken so long to get this going. But we're all very excited to be here and see our work pay off."

This victory was a long time in coming, as volunteers had worked for over two years to bring public health services to the county. Eleanor Clifton, a FPH member from Rantoul, said, "We've been at every Board of Health meeting, at the Policy, Procedures, and Appointments Committee meetings, at

Budget and Finance Committee meetings, and at County Board meetings. We're very pleased to see the levy pass, and we are eager for more progress." Clifton went on to say that Coalition members are glad to have a break. "We need a rest," she said.

Even now, FPH members are continuing to work on getting services started for County residents. Several FPH members attended the December 10th meeting of the Board of Health, where the Board and Gale Fella discussed the contract with the C-U Public Health District at length. Board of Health members expressed concern about the details for when the contract expires with the CU-PHD. Many options are available, including renewing the agreement and ending the contract at its full term so that the County Health Department can function independently, if they feel they are ready to do so.

Both the Board of Health and the CU-PHD seemed to be willing to negotiate a contract that would satisfy everyone, and Friends of Public Health members were glad to see the cooperation at the meeting. Claudia Lennhoff, CCHCC Organizer, said, "It's great to see the Board of Health members really get engaged in the decisions that need to be made. Now it looks like they are ready to take on the challenge and to do the best job they can," said Lennhoff. "We're very excited, and we support their efforts." FPH members will continue attending Board of Health and County meetings and will hold their own monthly planning meeting the first Saturday of each month at the CCHCC office at 10:30 a.m. ≤

Health Insurance and Medical Bil

Advocates' Advice: Problems with Medical Billing or Expenses

Unfortunately, a number of people in the US (one recent estimate was 15%) lack any kind of health insurance, and many others have coverage that is inadequate to cover their actual expenses. Imagine being presented with a bill for thousands of dollars and told you have ten months to pay it, while the balance accrues interest charges that by themselves are more than you can afford to pay monthly.

In order to pay medical bills, people are mortgaging their homes, compounding their situation by charging medical costs on their credit cards, taking out bank loans, or being taken to court and having their incomes garnished. They are also being refused further treatment, unless unreasonable payment schedules are met, even in cases where they have managed to obtain insurance and current bills are covered.

Structural changes in our health care system are called for, but there are a few things consumers can do to help themselves in such situations.

If you know you will need an expensive medical procedure and it's not an emergency, ask for an accurate written estimate of charges in advance and do some comparison shopping, taking into account, of course, the skill and training of the practitioner, along with billing policies and interest charges. One of our Hotline clients saved \$1,000 on surgeon's fees by doing this. You have the right to request that copies of your medical records be released (without charge) to other health care providers for this purpose, or to you, for a charge equal to the expense of reproduction.

In non-emergency situations,

research your illness at the library or on the internet. Second opinions from physicians at other institutions are often valuable, and sometimes save you far more than they cost. You have the right to obtain medical records, test results, and X-rays for this purpose.

Make payment arrangements in advance of treatment. If you will need financial help, there are some sources of assistance in our community.

Some people may be eligible for government assistance, or for the programs offered by local hospitals to people of limited means. You'll almost always have to ask about these resources, and in the case of Medicaid, you'll go through a lengthy and troublesome bureaucratic process, but it's worth exploring. Income-qualified persons on Medicare may be able to get assistance with their 20% copayment via Medicare 100, a joint program from CCHCC and Covenant.

Read the credit agreement you sign with the medical provider, and request a copy. It is especially important to obtain a written agreement, as we've had several cases recently where a medical institution reneged on an agreement, insisting on higher monthly payments.

Read the fine print on the back of your medical bills where finance charges and credit terms are stated. If you still don't fully understand the terms, call and ask to have them explained so that you can understand.

If your bill is not itemized with procedure codes, request such a statement. When you receive it, examine it closely to be sure you received all the services billed and that the charges are reasonable.

Check to see when payments were credited and checks were cashed. If

the checks are cashed before payment is credited, you should protest.

If you are charged interest, and can't figure out how it was calculated, insist that the provider give you an understandable and rational explanation. If you do not understand your statement, you have the right to have it courteously explained to you.

Protest the statement if you think it contains errors. If your questions are not fully resolved, dispute the bill in writing, clearly stating questions and objections. This process should put finance charges on hold until the bill is corrected or you are satisfied that it is correct, or at least put you in a much better position with overdue payments if the problem is not resolved.

Keep a log of all correspondence and telephone calls you make and receive concerning your bills, including the name of the person you spoke to.

HAN Fights for Changes Managed Care Plans

The Health Action Network (HAN) is preparing for action on a problem that is hurting a growing number of consumers. Recent local news stories have focused attention on the fact that some managed health care organizations are cutting costs by denying coverage of medical procedures they label "experimental." Many of these procedures are not really new, and in fact are well established in the medical community. Moreover, in many cases such procedures are the only possibility for saving the patient's life. Organ transplants (common enough to be a donor check-off on driver's license applications) and some cancer treatments are among the measures that frequently are turned down for coverage.

If an individual consumer fights long enough, the insurance company may give in and cover the needed procedure, but there are two major problems with this situation: (1) most consumers don't have the time or the

records. These can be immensely valuable in resolving billing disputes or assessing reasonableness of charges.

If you have had or are having unresolved billing problems and need advice and assistance, call CCHCC. Your call will be confidential, unless you specifically state that you are willing to have your information shared.

We have a number of helpful information sheets and packets, as well as Hotline volunteers to advise you. To reach one, call 352-6533 during office hours Monday through Friday.

Finally, write or phone your legislators. Tell them how the present system is affecting you. Vote for those who support adequate, affordable care. It's false economy to allow hard working people to slide into poverty as a result of medical expenses which they can't control, or to become disabled because they are refused prompt and necessary treatment. ≤

knowledge needed to wage a lengthy battle, and (2) even if they do, some of them will become incapacitated or even die for lack of the very treatment that they are fighting to obtain.

According to John Cameron of Citizen Action of Illinois, the Managed Care Bill of Rights—which is contained in HB 626—does address the question of insurance coverage of individual procedures. The bill would mandate that the deciding factor in whether a treatment is covered is whether it is deemed "medically necessary" by the doctor. If coverage still is denied, an appeals procedure involving an independent review process is guaranteed.

The Fall 1997 session of the Illinois Legislature ended with HB 626 stalled in a subcommittee of the state Senate. It will become an issue again in the Spring 1998 session. The Health Action Network will be calling for early and sustained support for the bill. Look for an Action Alert in January. ≤





The Dental Referral Program (DRP) of the Champaign County Health Care Consumers is pleased to announce that Frances Nelson Health Center is willing to give specialist referrals to DRP clients. This means that people that need special care for their teeth that cannot be taken care of by a general dentist can be referred to Carle, or Christie Clinics. The treatments used at these clinics is not free, but will be charged at Frances Nelson B-Scale sliding rates (based on family income). An important condition of the agreement is that the patient in need must be a regularly scheduled patient at Frances Nelson.

Additionally, services that can be used by Champaign-Urbana residents include the C-U Public Health and Parkland College, At the C-U Public Health District any resident between the ages of 3-18 can get free general dentistry along with children that live in Champaign county that have a Medical Card. Parkland offers teeth cleaning at a rate of \$10.00 for anyone. The cleaning is completed by student dental hygienists and you may need to make a couple of appointments to get your entire mouth cleaned. The CCHCC Senior Task Force would like to announce new improved discounts on prescription drugs for members of the Medicare 100 and Medicare Plus programs.
